Discussion:

On February 16th, the Department of Homeland Security released its 2016 Homeland Security Grant Program Notice of Funding Opportunity, which includes the FY16 UASI grant award for the Bay Area. The Bay Area UASI grant allocation for FY16 is \$28,036,000, a decrease of approximately 1% from the FY15 allocation.

Proposed Bay Area UASI FY16 grant allocations are detailed below in Table 1, with the FY15 allocations included for reference.

Hub Allocations:

There is \$5,382,272 available for allocation to hubs out of the FY16 grant award. This amount is distributed to the four hubs based on the risk allocation percentage approved by the Approval Authority in the March 2016 meeting (East = 24.3%; North = 8.2%; South = 24.7%; and West = 42.9%). Table 3 below shows the proposed FY16 hub allocations, the FY15 amounts, and percentage change.
