Public Participation:

It is the policy of the Approval Authority to encourage and permit public participation and comment on matters within the Approval Authority's jurisdiction, as follows.

- Public Comment on Agenda Items. The Approval Authority will take public comment on each item on the agenda. The Approval Authority will take public comment on an action item before the Approval Authority takes action on that item. Persons addressing the Approval Authority on an agenda item shall confine their remarks to the particular agenda item. For each agenda item, each member of the public may address the Approval Authority once, for up to three minutes. The Chair may limit the public comment on an agenda item to less than three minutes per speaker, based on the nature of the agenda item, the number of anticipated speakers for that item, and the number and anticipated duration of other agenda items.
- General Public Comment. The Approval Authority shall include general public comment as an agenda item at each meeting of the Approval Authority. During general public comment, each member of the public may address the Approval Authority on matters within the Approval Authority's jurisdiction. Issues discussed during general public comment must not appear elsewhere on the agenda for that meeting. Each member of the public may address the Approval Authority once during general public comment, for up to three minutes. The Chair may limit the total general public comment to 30 minutes and may limit the time allocated to each speaker depending on the number of speakers during general public comment and the number and anticipated duration of agenda items.
- *Speaker Identification*. Individuals making public comment may be requested, but not required, to identify themselves and whom they represent.
- Designated Public Comment Area. Members of the public wishing to address the Approval Authority must speak from the public comment area.
- Comment, Not Debate. During public comment, speakers shall address their remarks to the
 Approval Authority as a whole and not to individual Approval Authority representatives, the
 General Manager or Management Team members, or the audience. Approval Authority
 Representatives and other persons are not required to respond to questions from a speaker.
 Approval Authority Representatives shall not enter into debate or discussion with speakers during

public comment, although Approval Authority Representatives may question speakers to obtain clarification. Approval Authority Representatives may ask the General Manager to investigate an issue raised during public comment and later report to the Approval Authority. The lack of a response by the Approval Authority to public comment does not necessarily constitute agreement with or support of comments made during public comment.

Speaker Conduct. The Approval Authority will not tolerate disruptive conduct by individuals
making public comment. Speakers who use profanity or engage in yelling, screaming, or other
disruptive behavior will be directed to cease that conduct and may be asked to leave the meeting
room.

REGULAR MEETING MINUTES DRAFT

1. Roll Call

Chair Kronenberg called the meeting to order at 10:02 am. General Manager Craig Dziedzic took roll. Chair Anne Kronenberg, Members Raymond Guzman, David Hober, Sherrie Collins, Mike Casten, Christopher Helgren and Brendan Murphy were present. Vice-Chair Rich Lucia and Member Carlos Bolanos were absent, but their alternates, Brett Keteles and Jeff Kearnan, were present. Member Ken Kehmna arrived at 10:05 a.m. and Member Renee Domingo arrived at 10:16 a.m.

2. Approval of the Minutes

3. General Manager's Report

(a) Management Team Staff Update

Public Health Project Manager Position

UASI General Manager Craig Dziedzic stated that Lani Kent, the public health project manager, will be leaving the UASI Management Team. She has accepted a position as Senior Health Advisor to Mayor Edwin M. Lee in the City and County of San Francisco. Her last day will be October 11, 2013.

The Management Team will be working with the San Francisco Department of Human Resources to begin the recruitment process to fill the position. Catherine Spaulding and

Janell Myhre will be the points of contact for the recruitment process. Since the position will manage a number of projects within the citizens' preparedness portfolio, the Management Team has renamed it as the Resilience and Recovery Project Manager position. The position will be responsible for developing and implementing regional program and project planning with a focus on citizen preparedness, emergency planning, resiliency, recovery, and health and medical preparedness.

Statewide Risk Management Position

Mr. Dziedzic stated that Captain Kevin Jensen of the Santa Clara County Sherriff's Office has announced his retirement from the Sheriff's Office. Since 2012, Captain Jensen has managed the CA Statewide Risk Management program, working with the CA Coalition of UASIs (CCU) and Digital Sandbox to ensure that each CA UASI has access and technical assistance to the various modules offered under the master contract with Digital Sandbox. Captain Jensen was also managing best practices for the CCU. Prior to managing the CA Statewide Risk Management program, Captain Jensen was assigned to the Bay Area UASI Management Team as the project manager for the Bay Area's regional risk management projects.

The California Coalition of UASIs will discuss this position at the next scheduled meeting on October 31, 2013.

(b) Grant Applications Update

Mr. Dziedzic reported that on September 27, 2013, Federal Emergency Management Agency notified the Management Team that the two applications submitted for the FY 2013 Homeland Security National Training Program (HSNTP) Continuing Training Grants (CTG) had been turned down. The reason stated was that other applicants had been selected through the competitive process. The Management Team is following up with FEMA to obtain information on the selected applications and to seek advice as to how we can improve such applications for future consideration.

(c) Bay Area UASI Legal Services Contract

Mr. Dziedzic stated that the legal services contract with Myers & Nave will expire on December 31, 2013. He explained that the original legal service contract had been in the amount of \$47,500 for a one year term (12/1/11-12/31/12) and that the Management Team has already extended the term for an additional year (through 12/31/13). So far, invoices paid through August 2013 amount to \$34,085.24 with the average monthly billing amounting to \$1,623. The Management Team recommends allowing this contract to conclude without an additional extension.

Members Hober, Kehmna and Domingo inquired if there was an on-call option for legal services from Myers & Nave if they were required in the future. Mr. Dziedzic informed them that he would look into an on-call option.

4. Bay Area Homeland Security Strategy

Josh Filler presented a PowerPoint on the Bay Area Homeland Security Strategy. Mr. Filler stated that the purpose of the Strategy is to ensure the Bay Area region has a comprehensive document and system that outlines the region's risks, capabilities, vision, structure, goals and objectives for homeland security. Having such a strategy will ensure the Bay Area is in the best possible position to clearly track and articulate its risk and capability needs to local leaders, the State of California, and the U.S. Department of Homeland Security when seeking resources and funding to enhance homeland security and public safety across the region. The Homeland Security Strategy is also a requirement of FEMA in order to receive Homeland Security Grant Program funding.

5. Priority Capability Objectives for FY14 Funding Cycle

Assistant General Manager Catherine Spaulding stated that the Bay Area's risk management program identifies capabilities that are the most "risk relevant" and where gaps in capability are of the greatest significance so that the region may target investments in this area. This prioritized and strategic approach is consistent with federal requirements and frameworks.

Ms. Spaulding stated that the Management Team developed the 2013 priority capability objectives based on the risk and gap analysis presented in the 2012-2015 Bay Area Homeland Security Strategy. Most of the core capabilities that had gaps indicating "needs extra attention" or "needs attention" have been included in the priority capability objectives. In addition, several core capabilities that are particularly relevant to the highest risk hazards faced in the Bay Area have been included given the critical need to sustain such capabilities.

6. Bay Area Incident Management Teams Assessment and Frameworks

CBRNE Project Manager Bruce Martin presented a report on Bay Area Incident Management Teams. Incident Management Teams are teams of people trained in various National Incident Management Systems (NIMS) positions to provide general non-operational work (e.g. planning, logistics, information) at larger, emerging incidents. The report was prepared by Citygate Associates and was the result of cross-disciplinary stakeholder e meetings. The study makes ten recommendations consistent with its findings.

Alternate Member Kearnan inquired about reimbursement to the participating agencies that are on these Incident Management Teams. Mr. Martin stated that participation in the Incident Management Team is covered under mutual aid agreements between cities and counties.

Reimbursement will only occur when the Federal Government or another entity reimburses the team.

7. South Bay Computer Aided Dispatch to Computer Aided Dispatch Project Update

Santa Clara County Communications Director Bert Hildebrand and Santa Clara County Senior IT Project Manager Eric Tingom presented a PowerPoint on The Silicon Valley Regional Interoperability Authority Project (SVRIA), which proposes to link the Public Safety Answering Point (PSAP) centers in both Santa Clara County and Santa Cruz County through their associated Computer Aided Dispatch (CAD) software. This will allow electronic sharing of data across multiple agencies and jurisdictions and improve the dispatching of fire and medical resources.

8. Update on FY11 UASI Grant Spending

Chief Financial Officer Tristan Levardo stated that the Management Team has processed about \$4M in claims to the FY 11 UASI grant since the August 8, 2013 Approval Authority meeting. He indicated that overall cumulative spending is at 57% and the deadline for most project deliverables is November 30, 2013. Mr. Levardo has not seen any significant reimbursement requests from Contra Costa, Palo Alto, Santa Clara, and Watsonville and he has urged all jurisdictions to submit their claims as soon as payment has been made to the vendor.

9. Grants Manual

Assistant General Manager Catherine Spaulding presented the Grants Manual for review and stated that the document provides the standards, policies, and processes that govern grant and project management and administration for the Bay Area UASI. The purpose of the Manual is to provide clarity and transparency around Bay Area UASI grant and project management and ensure efficiency and compliance in implementation. Ms. Spaulding stated that the Management Team has made considerable clarifications and enhancements to the document in order to bring it into better alignment with current practices. The changes increase the transparency and accountability of the operation as well as remove redundant steps to improve efficiency.

10. Urban Shield 2013

Alameda County Sheriff's Captain Garrett Holmes presented a PowerPoint on Urban Shield 2013. Urban Shield is a continuous, 48-hour Full Scale Multi-Disciplinary Homeland Security/Disaster Preparedness Exercise hosted by the Alameda County Sheriff's Office. With the support of the UASI and more than 200 local, state, federal, international and private sector partners, the event will run from Friday, October 25, 2013 to Monday, October 28, 2013.

Capt. Holmes stated that during Urban Shield, first responders are presented with exercise scenarios that incorporate key elements of real-world emergencies and major critical incidents at various scenario sites in Alameda, Contra Costa, San Francisco, San Mateo and Santa Clara counties. The exercise includes: 31 tactical scenarios, 18 fire scenarios, 6 explosive ordnance disposal scenarios, 4 medical checkpoints, a mass fatality exercise and a technology showcase.

11. Report from the Bay Area Regional Interoperable Communications System Joint Powers Authority (BayRICS JPA)

Barry Fraser, General Manager of the BayRICS JPA, reported that the BayRICS JPA Board of Directors held a special meeting on September 16, 2013. The Board received an update on the status of Spectrum Lease negotiations with FirstNet. Mr. Fraser stated that the BayRICS spectrum lease agreement with FirstNet has been furloughed since October 1, 2013 due to the federal government shutdown. The next meeting with FirstNet on October 17, 2013 will probably be canceled due to the government shutdown.

12. Tracking Tool

Chair Kronenberg asked the Board for any questions or comments. There were no questions or comments.

13. Announcements-Good of the Order

Member Helgren provided an update on the North Bay planner position and indicated that two very qualified candidates were interviewed. They plan to make a job offer soon.

Member Hober announced that San Jose Fire Deputy Chief Colleen Mulholand will be serving as the San Jose alternate for Approval Authority meetings.

Discussion/Description:

(a) UASI FY 2014 Project Proposal Update (Discussion Only)

On October 3, 2014, the Management Team hosted the FY 2014 BAUASI Project Proposal Submission Process Kickoff meeting at the Alameda County Sheriff's Office. The objective of the meeting was to provide information about submitting project proposals for consideration of UASI FY14 grant funding. The Management Team discussed the project proposal template, electronic submission process, proposal selection criteria and process, timelines, and grant requirements.

According to the feedback, the Kick-off meeting was successful. There were approximately 50-60 attendees and 40 others who participated via webinar. The meeting was recorded for future reference and the recording can be downloaded from our website.

(b) Coalition of CA UASIs Update (Discussion Only)

The Coalition of CA UASIs (CCU) held its quarterly meeting in Sacramento on October 31 and November 1. All the CA UASIs attended; except for Ventura and Bakersfield which were defunded from the UASI federal grant allocation. Representatives from the State of CA, including the Director of CalOES, Mark Ghilarducci, and Deputy Director Brendan Murphy also attended as well as representatives of Digital Sandbox, Inc (DSI).

The group discussed the THIRA process and working with the State of CA to assure alignment with the threats and hazards of the state. The group also discussed the CA Risk Management Contract with Digital Sandbox, Inc. to ensure that all the jurisdictions receive the services as stated in the contract. The group agreed to continue with the Statewide Risk Manager's Position but will define the scope and deliverables to include the additional DSI projects.

(c) The National Fusion Center Association (NFCA) Annual Training Event

The National Fusion Center Association (NFCA) Annual Training Event occurred November 5th through November 7th. Mike Sena of the NCRIC and the President of NFCA held the event in Washington, DC. Representatives from federal, state, and local agencies participated in training sessions and discussed strategies and best practices for information and sharing, outreach/training, collaborations. Keynote speakers included the Honorable Rand Beers, Acting Secretary of Defense, the Honorable Nick Rasmussen, Principal Deputy of the National Counterterrorism Center, and the Honorable James Comey, FBI Director, who discussed the evolving threats and risks facing the nation and the need to leverage security with information and sharing collaborative efforts. Dave Fraser, UASI Risk & Info Sharing Project Manager, Caroline Thomas-Jacobs (Regional East Bay Planner), and I attended this informative training.







 - Complies with national guidelines, agency standards and regulations










County Asset Risk






Hub Asset Risk





- Volunteer Management
- Donations Management
- Logistics and Critical Lifelines

All of the plans were validated and delivered in 2012, with the exception of Logistics and Critical Lifelines which will be delivered this calendar year. The plans include one multi-county regional plan and one individual plan with local information customized to the local jurisdiction for each of the eleven local counties and three major cities in the Bay Area UASI footprint.

RCPGP plans have been developed for regional adoption as annexes to the Cal OES Coastal Region's San Francisco Bay Area Regional Emergency Coordination Plan (RECP) and for local adoption to county and core city emergency operations plans.

Without finalizing RCPGP regional and local plan adoption, over \$14 million in tax dollars and thousands of staff hours throughout the Bay Area devoted to producing the plans and supporting projects will not be sustained. Neither local Operational Areas (OAs) nor Cal OES will exercise, maintain, or update plans that are not adopted. Adopting the plans at the local and regional level will bring OAs and the region into compliance with presidential and FEMA directives.

Progress on RCPGP Plan Adoption

We are pleased to report progress on the state's adoption of the RCPGP plans since the May 2013 report:

- The Bay Area UASI Management Team conducted plan validation exercises for all eight RCPGP regional plans during tabletop (TTX) exercises and Urban Shield. Over 300 people attended the RCPGP tabletop series and approximately 5,500 people attended the Urban Shield Full Scale Exercise. Please see Appendix A for a summary of related RCPGP TTX After Action Meeting (AAM) comments.
- Cal OES and Cal OES Coastal Region have committed to accepting the RCPGP regional plans in their current draft format. Appendix B is a letter of acknowledgment from Cal OES Coastal Region Administrator, Jodi Travesaro.
- Cal OES Coastal Region supports the local Bay Area counties and core cities in adopting their local RCPGP plans per their jurisdictions' protocols. Most OAs have adopted their local plans or are in progress to do so. (See Table A below).
- Cal OES will provide final acceptance of the RCPGP plans once After Action Meeting (AAM) comments are addressed and a decision is made concerning the regional plans' relationship to the San Francisco Bay Area Earthquake Readiness Response: Concept of Operations Plan (CONPLAN).
- Once Cal OES provides final acceptance of the regional plans, they will post them to their website. This is expected to be completed by 2015.

The UASI Management Team will continue to work closely with Cal OES and support local efforts on plan adoption through completion.

EXECUTIVE SUMMARY

Regional Catastrophic Preparedness Grant Program Tabletop Exercise After Action Report DRAFT

The Regional Catastrophic Preparedness Grant Program (RCPGP) Tabletop Exercise (TTX) Series was developed to provide a forum to discuss the status of the RCPGP Regional Catastrophic Earthquake plans, identify strengths and areas of improvement within the plans and discuss next steps. The overarching goal of the exercise series was to bring together all levels of government and private sector stakeholders to have a positive, no-fault, open discussion on current and future Regional Catastrophic Earthquake planning efforts. The six TTXs were conducted in Dublin, California at the Alameda County Office of Emergency Services (OES) between July 9, 2013 and August 21, 2013.

Based on the exercise planning team's deliberations, the following overarching objectives were developed for the RCPGP TTX Series:

- 1. Review the major components of the Plan to vet and align Federal, State, Bay Area region and local government roles and responsibilities, notification and activation procedures.
- 2. Discuss critical elements identified during Golden Guardian 2013.
- 3. Identify gaps and develop recommendations for adoption of the Regional Catastrophic Preparedness Grant Program (RCPGP) plans as Annexes to the Coastal Region Regional Emergency Coordination Plan (RECP) and Local Government Emergency Operations Plans (EOPs).

The purpose of this report is to analyze exercise results, identify strengths to be maintained and built upon, identify potential areas for further improvement, and support development of corrective actions.

The major strengths identified during this exercise are as follows:

- The plans have been validated in recent years and many exercise participants were part of the planning efforts, vetting sessions and workshops providing a unique and important perspective on plan content and operations in the private sector and at all levels of government.
- Participants noted that the plans as currently developed are aligned with local, state and federal agency roles and responsibilities and follow SEMS regulations. Despite the areas that need updating, they supported the California Governor's Office of Emergency Services (Cal OES) approval and adoption of the plans.

- The exercise provided a forum to identify necessary updates and new information that can be included in future iterations of the RCPGP Regional Catastrophic Earthquake plans.
- Each tabletop exercise began with an educational session titled, "Comprehensive Plan Review" that provided an overview of the supporting planning documents from Federal, State, Coastal Region and Operational Area jurisdictions. Theses educational sessions were generally met with positive feedback and participants requested additional information about the plan relationships to be included in this After Action Report.

Throughout the exercise, several opportunities for improvement were identified. The primary areas for improvement are as follows:

- The level of knowledge and understanding of the RCPGP Regional Catastrophic Earthquake plans, Regional Emergency Coordination Plan (RECP) Base Plan and supporting plans was remarkably diverse.
 - Corrective Action: Continue to train on the plan integration and coordination aspect, including adding additional information in this After Action Report, distribution of the RCPGP Plan Analysis Report and by evaluating plans in upcoming exercise oppurtunities.
- The current unapproved status of the RCPGP Regional Catastrophic Earthquake Plans by Cal OES puts the operational areas and local governments in a difficult planning posture

 without the ability to clearly move forward utilizing these important tools.
 - Corrective Action: Cal OES Coastal Region will accept the Regional Catastrophic Earthquake plans as working drafts and work with the bay area UASI jurisdictions and the State Planning and Preparedness Branch to complete a plan review and revision process using identified RCPGP plan AAR gaps – with the ultimate goal of plan approval and adoption by mid-late 2015.
- The tabletop exercises identified opportunities for plan updates, including the use of the term "people with disabilities and others with access and functional needs (AFN)", referencing the California Department of Public Health (CDPH) Emergency Operations Manual (EOM) and the RCPGP Logistics and Restoration of Critical Lifelines Plan operations when completed.
 - Corrective Action: Cal OES Coastal Region will accept the Regional Catastrophic Earthquake plans as working drafts and work with the Bay Area UASI jurisdictions and the State Planning and Preparedness Branch to complete a plan review and revision process using identified RCPGP plan AAR gaps, including items related to AFN populations, the CDPH EOM and the RCPGP Logistics and Restroation of Critical Lifelines plan with the ultimate goal of plan approval and adoption by mid-late 2015.

Discussion:

Background

Utilization of Automated License Plate Reader (ALPR) technology has rapidly expanded throughout the Bay Area. In 2013, no fewer than 30 police and sheriff departments are employing these systems, with some operating more than ten fixed or mobile units. Through data integration and information sharing efforts led by the Northern California Regional Intelligence Center (NCRIC), Contra Costa Sheriff's Office, and Santa Clara Sheriff's Office, ALPR data is aggregated cross-vendor and cross-agency to present a unified regional system with regional access.

ALPR Focus Group

With further expansion of this technology expected, and the potential associated requests for regional UASI funding, UASI Risk/Information Sharing Project Manager David Frazer teamed with NCRIC IT Manager Brian Rodrigues, to form an "Automated License Plate Reader Technology Focus Group" to assess the current state of ALPR use in the Bay Area and define a regional strategy for the future. Membership included representatives from multi-jurisdiction agencies throughout the region, including the NCRIC, California Highway Patrol, Central Marin Police Authority, and the Sheriff's Offices of Alameda, Contra Costa, Marin, and Santa Clara Counties. The ALPR Focus Group met in person on July 31st and September 24th of 2013.

ALPR Focus Group Results

- <u>ALPR Asset Identification</u> –The Focus Group identified over 30 agencies in the Bay Area region that are using ALPR camera technology. Of those, approximately 75% employ devices by 3M/PIPS and 25% from Vigilant Video. Nearly all units are mobile attached to patrol or covert law enforcement vehicles.
- <u>Regional Data</u> The NCRIC has developed a regional data warehouse of all ALPR data coming in from law enforcement agencies in the Bay Area region and is available to all regional law enforcement.
- <u>Standards and Guidelines</u> In the absence of national or statewide regulations governing proper or permissible use of ALPR technology by law enforcement, agencies are left with the responsibility to define and document their own policies or procedures. The Focus Group agreed that achieving standardization and as much uniformity as possible throughout the region presents the strongest stance possible to both law makers and privacy-minded groups such as the ACLU. The NCRIC has invested considerable effort into defining its ALPR Guidelines, and offered this policy either for adoption or use as a starting point for other participants.
- <u>Identification of Strategic Locations</u> The Focus Group agreed that strategically selected high-traffic "choke points" present the most effective and cost-efficient locations to deploy new ALPR cameras. Examples include entrance and exits of major bridges and tunnels, or intersections of major expressways, where stolen vehicles or other actionable traffic is pervasive.
- <u>Lessons Learned</u> The Long Beach Police Department ALPR Program Manager (via video conference) shared valuable insight and guidance based on experiences building the ALPR Program for the Port of Long Beach/LA.


- Alameda County law enforcement agencies have agreed to join ARIES, increasing the number of agency users by 18.

- San Francisco PD is currently working with FBI N-DEX to integrate their data. N-DEX will exchange this data with CopLink and then ARIES after full of integration of CopLink and ARIES.

Report from General Manager of the BayRICS Authority on the activities of the BayRICS Authority for October 2013.

Discussion/Description:

1. BayRICS Administration

The regular BayRICS Board meeting scheduled for October 10 was cancelled. The BayRICS Authority's next regular meeting is scheduled for Thursday November 14 at 1:30 PM, at the Alameda County Sheriff OES in Dublin.

Staff has completed a financial audit for Fiscal Year 2012-2013. The audit report is available at http://www.bayrics.net/uploads/1/2/4/6/12466172/final bayrics financial audit fy 2013.pdf

BayRICS Director Jim Bouziane (South Bay Hub) and Alternate Director Chris Godley (San Jose) have resigned from the Board. Director Bouziane will be replaced by Captain Dan Winter with the City of Santa Clara Police Department. Alternate Director Godley's replacement will be named later.

2. Staff Activities

GM Fraser spoke at the California Emergency Services Association (CESA) annual conference in Santa Rosa, CA on October 16, 2013. Fraser spoke on a panel with Karen Wong and Michael Crews (Cal-OES), and Pat Mallon (LA-RICS) on the topic of FirstNet and the Nationwide Public Safety Broadband Network.

3. FirstNet and Spectrum Lease Negotiations.

FirstNet activities and spectrum lease negotiations were delayed by the federal government shutdown from October 1-October 16. The FirstNet Board Meeting scheduled for October 17 in Concord, CA was cancelled, and several negotiating sessions between BayRICS and FirstNet staff had to be rescheduled

As of the date of this report, BayRICS has not yet executed a spectrum lease. GM Fraser and BayRICS officers have continued to meet with FirstNet and Motorola during and after the federal government shutdown, with the goal of completing the negotiations by the first week of November. Outstanding issues involve a request by FirstNet to make several changes to the "BOOM" master agreement with Motorola Solutions, Inc. Changes include revisions of certain technical specifications, revenue sharing arrangements with FirstNet and changes to the timing of the transfer title to the BayWEB system from Motorola to BayRICS.

The FirstNet Board held a meeting by teleconference on October 25 and took action on the following items:

- The spectrum lease negotiation deadline for BayRICS was extended until Friday, Nov 15th, 2013.
- FirstNet is still negotiating for spectrum leases with BayRICS/Motorola, Mississippi, New Jersey, and Adams County, Colorado.
- FirstNet voted to establish headquarter offices in Northern Virginia, and technical headquarters in Boulder Colorado.
- They plan to stand up 10 satellite offices, one in each of the FEMA regions, but exact locations have not been announced.
